Ms. Lim currently holds pivotal roles in corporate governance. She serves as the lead independent director for Far East Hospitality Asset Management and Far East Hospitality Trust Management, overseeing the management of the Far East Hospitality Trust. 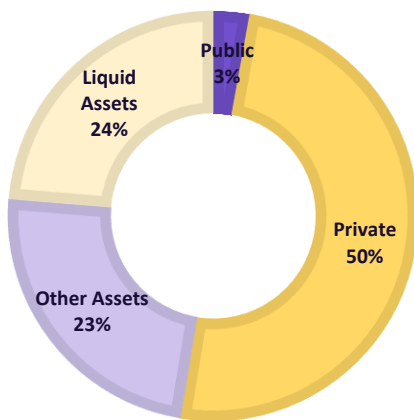
